

Method of study

The course is delivered online and designed to be flexible around your professional and personal life. There are six modules, plus an exam at the end of the course. In each module, you have access to eLearning, reading, case study and a quiz. You also have access to live consolidation sessions, where a tutor will take you through the module, case study, and any tricky elements of learning. Each module is expected to take you one month. You are given a further two months to complete your exam and complete any further outstanding work. After this time, the course will end, and you will no longer have access to these materials.

Course description

This course will develop your techniques and essential skills required to achieve successful project delivery.

As a project manager, you will be responsible for managing the construction project lifecycle from start to finish. This means managing the development process from initially working with clients on their requirements, through the design, procurement and construction stages, to the final handover.

Competency in this area will enhance your skillset as a construction professional and ability to ensure successful project completion.

Learning outcomes

- 2. Recognise the legal and contractual constraints of a project
- 3. Recognise the challenges faced and requirements of a project manager at all stages of a construction project
- 4. Apply effective cost control and reporting measures during the construction phase of a project and
- 5. Perform risk management and analysis techniques to a project.

Learning resources

The resources in each technical module include various learning components to ensure you achieve the right level of knowledge for each competency.

eLearning - Interactive and responsive eLearning modules deliver the technical content of the learning objectives. The content will be delivered in bite-size chunks, including examples, top tips, scenarios and interactive activities. Please select the 'Exit course' button at the top right-hand corner of the screen before closing the eLearning. This is to ensure your progress is saved.

Reading materials - Each module is supported by structured reading materials such as professional guidance and standards, videos or the latest insight articles and research.

Essential reading files require you to view all files for the section to be marked as completed.

Further reading materials have been provided should you wish to expand your knowledge a bit further, but they are not mandatory.

Discussion forum - Forums are a great social learning tool for you to share information and experiences with your fellow students about the course topics, how they apply to you and/or your industry as well as to ask questions to your trainer. There is one discussion forum per module.

Case study - Every module has a graded case study for you to apply what you have learned in a more practical sense. The tutor will review your submission and provide you with feedback on your strengths, areas for improvement, and actions to take.

Submissions are allowed from the date the module is released. Please refer to the course calendar for case study deadlines. The system will allow you to submit your case study after the deadline; however, it will be displayed as late, and it might not be graded. A model answer for each case study is released a day after the case study deadline. You must submit your case study for this activity to be marked as completed.

Consolidation session - This is a one-hour live webclass that consolidates learning from the e-learning modules, reading materials, case studies and common questions that have been raised in the forum. The recording of the session will be provided in case you miss the live session along with the slides from the session. You do not need to mark this activity as completed.

End of module quiz - A short assessment at the end of each module tracks your progress in the course. Quizzes do not have a passing grade, but you must attempt them to have the activity marked as completed.

End of course exam - The exam will be available on the date shown on the course calendar. The exam consists of 50 multiple-choice questions. The passing grade is 65% and you will have one hour to complete it. You are allowed 2 attempts; however, the second attempt is only released 24 hours after the first attempt.

Your certificate can be downloaded once you have passed the exam and answered the feedback survey.
