You are given a further two months to complete your exam and complete any further outstanding work. After this time, the course will end, and you will no longer have access to these materials.

Course description

Facilities Managers can influence how a company's operating costs can be reduced while its productivity is increased. It is essential to ensure that all the different buildings and services of a company work as efficiently as possible. Facilities management is the total management of all services that support the core business of an organisation, and good facilities management makes a huge difference to the efficiency and productivity of a company, its staff and even its clients.

Our course will equip you to recognise the factors that influence property choice, nature of tenure and acquisition and disposal of corporate real estate. This includes the cost implications of the property life cycle and the consideration of liabilities and legal issues. You will also be able to apply the techniques you learn to improve workplace productivity, sustainability, communication and the overall competitive strategy of an organisation.

Learning resources

The resources in each technical module include various learning components to ensure you achieve the right level of knowledge for each competency.

eLearning - Interactive and responsive eLearning modules deliver the technical content of the learning objectives. The content will be delivered in bite-size chunks, including examples, top tips, scenarios and interactive activities. Please select the 'Exit course' button at the top right-hand corner of the screen before closing the eLearning. This is to ensure your progress is saved.

Reading materials - Each module is supported by structured reading materials such as professional guidance and standards, videos or the latest insight articles and research.

Essential reading files require you to view all files for the section to be marked as completed.

Further reading materials have been provided should you wish to expand your knowledge a bit further, but they are not mandatory.

Discussion forum - Forums are a great social learning tool for you to share information and experiences with your fellow students about the course topics, how they apply to you and/or your industry as well as to ask questions to your trainer. There is one discussion forum per module.

Case study - Every module has a graded case study for you to apply what you have learned in a more practical sense. The tutor will review your submission and provide you with feedback on your strengths, areas for improvement, and actions to take.

Submissions are allowed from the date the module is released. Please refer to the course calendar for case study deadlines. The system will allow you to submit your case study after the deadline; however, it will be displayed as late, and it might not be graded. A model answer for each case study is released a day after the case study deadline. You must submit your case study for this activity to be marked as completed.

Consolidation session - This is a one-hour live webclass that consolidates learning from the e-learning modules, reading materials, case studies and common questions that have been raised in the forum. The recording of the session will be provided in case you miss the live session along with the slides from the session. You do not need to mark this activity as completed.

End of module quiz - A short assessment at the end of each module tracks your progress in the course. Quizzes do not have a passing grade, but you must attempt them to have the activity marked as completed.

End of course exam - The exam will be available on the date shown on the course calendar. The exam consists of 50 multiple-choice questions. The passing grade is 65% and you will have one hour to complete it. You are allowed 2 attempts; however, the second attempt is only released 24 hours after the first attempt.

Your certificate can be downloaded once you have passed the exam and answered the feedback survey.
