The RICS Sustainability Conference 2026 brings together professionals from across the built and natural environment sectors for a full day of insight, collaboration, and practical learning on how nature-positive sustainability practices can be embedded across the property lifecycle. Beginning with registration and networking, the event opens with a keynote that sets the tone for a programme focused on integrating environmental responsibility into industry practice. A headline panel discussion explores how digital tools, partnerships, and data-driven approaches can help deliver measurable improvements in the sustainability of developments.

For a section of the morning, attendees can choose between parallel breakout streams that are more relevant to their practice. Sessions explore how biodiversity can be integrated into asset valuation and investment decisions, nature risk during landscape planning, and how environmental considerations can shape site selection, consent strategies, and long-term land stewardship. Later sessions highlight case-studies for nature-positive commercial developments and conversations between project managers on how sustainability considerations can be embedded from initial design, through to construction and completion.

In the afternoon, the conference shifts its focus to future skills, professional standards, and inclusive approaches to integrating sustainability in the built environment. Discussions examine how industry professionals can develop the capabilities needed to deliver sustainable outcomes while fostering collaborative cultures that support the adoption of climate-friendly standards. The programme concludes with a *Sustainability in Action* case study session and a forward-looking address on the skills required for the next generation of professionals, before closing remarks bring together the day's insights and outline the path ahead for sustainability leadership across the built and natural environment.

## Stream one: Valuation and Investment

### Addresses & joint Q&A - Measuring what matters - valuing biodiversity in practice

Exploring emerging approaches including natural capital accounting, biodiversity net gain metrics, risk-adjusted cashflow modelling and disclosure frameworks, this session will examine how biodiversity considerations are being integrated into valuation methodologies, investment decision-making and portfolio strategy, moving beyond narrative ESG commitments toward quantifiable impact.

## Stream two: Planning & Development

### Addresses & joint Q&A - Nature risk & landscape planning - embedding sustainability into site selection, consent strategy and long-term land stewardship

## Stream one: building surveying and commercial property

### Case-study-led address: Designing with carbon sinks to ensure nature-positive commercial developments

As biodiversity expectations grow across planning policy, investor mandates and occupier demand, commercial developments are increasingly expected to demonstrate measurable environmental value. This session will include key case studies from commercial developments from a leading firm, discussing how they have used sinks to offset the carbon contributions of their projects.

## Stream two: Quantity surveying and project management

### Fireside chat: Aspirational management: embedding sustainability considerations from site to completion

Two leading project managers come together to discuss collaboration across the design and delivery stages of a landmark project. Drawing on the experience of one or multiple significant developments, the speakers will discuss how teams collaborate with ecologists, designers and contractors to translate biodiversity commitments into measurable outcomes on site. Delegates will gain practical insight into procurement strategies, risk management approaches and project governance mechanisms that help ensure biodiversity targets are delivered in practice, not just promised in planning documents.

### **Addresses: Nature for all – Inclusive approaches to biodiversity in the built environment**

Drawing on current policy drivers and industry practice, these addresses will examine how green-blue infrastructure and nature-based solutions can deliver multiple benefits - from climate resilience to health and wellbeing - while addressing the growing “nature gap” between communities. Central to the discussion is the idea of inclusive biodiversity, ensuring equitable access to nature through thoughtful, people-centred design that reflects diverse needs and local contexts. Through case studies and cross-disciplinary insights, speakers will highlight the importance of community engagement, co-design, and collaboration in delivering meaningful outcomes, alongside emerging approaches to measurement, policy alignment, and investment. The session ultimately positions biodiversity as essential infrastructure, challenging professionals to create places where nature and people can thrive together.
